Applicable to electric service for the operation of traffic control devices owned and operated by a municipality or government agency and located on a public street or highway. After December 31, 2019, TC-U is not available for new premises.

### MUNICIPAL FRANCHISE FEE:

A School Flasher is defined as a yellow flashing signal light in a school zone.

#### Traffic Flasher:

A Traffic Flasher is defined as a red or yellow flashing signal light.

#### Traffic Device:

A Traffic Device is defined as traffic control related equipment not defined as School Flasher or Traffic Flasher.

### TERM OF CONTRACT:

One (1) year.

### GENERAL TERMS & CONDITIONS:

The bill calculated under this tariff is subject to change in such an amount as may be approved and/or amended by the Georgia Public Service Commission under the provisions of applicable riders and other schedules.
